Kindly read the instructions carefully before you submit the application form:

- <u>SC Judgement</u>: The Hon'ble Supreme Court of India has held in the case of Society for Unaided Private Schools of Rajasthan v/s U.O.I. & Others Writ Petition (C) No. 95 of 2010, that the provisions of the Right of Children to Free and Compulsory Education Act 2009 (RTE) shall not apply to Unaided Minority Educational Institutions. The National Commission for Minority Educational Institutions, Government of India, New Delhi has declared Sacred Heart Sr. Sec. School, to be a Minority Educational Institution within the meaning of Section 2(g) of the NCMEI Act. Sacred Heart Sr. Sec. School, Sector 26, Chandigarh, therefore, being a certified Christian Minority, Unaided Educational Institution, does not reserve 25% seats for the E.W.S. (Economically Weaker Section) as mandated in the Right of Children to Free and Compulsory Education Act 2009. The school imparts education to the Christian computing and extends its service to the members of other communities to the actual content of the Christian Community and extent possible. community around and extends its service to the members of other communities to the extent possible.
- 2. There are 5 printed pages in the form. Kindly ensure you have filled and submitted all the pages.
- 3. Only those girls born between 1st April, 2021 and 31st March, 2022 will be eligible for Nursery admission for the academic year 2025-26. If your child is not within the age limit specified, she will NOT be considered for admission.
- 4. There will be no screening of the children or their parents. Preference will be given to applicants staying in nearby areas(of Sacred Heart Senior Secondary School), Christians, Siblings, Wards of Alumni, Management and Wards of Staff(Conditions apply) Kindly Note: Preference does not guarantee admission
- 5. Forms shall be available on the school website from 21st December, 2024 to 4th January, 2025. Selection for free and open seats, if available after allocation of other seats will be made by draw of lots on 20th January, 2025 at 3:00 p.m.
- 6. Only filled in application forms along with photocopies of relevant documents duly attested/notarized gazetted officer should be deposited in the school on 7th and 8th January, 2025 (from 12:30 pm to 2:30 pm) along with a payment of Rs 150.
- 7. Incomplete forms/those filled with incorrect information/unattested forms or forms without all the required documents, will NOT be considered for admission.
- 8. No enquiries will be entertained at the reception counter during the days of submission of forms.
- 9. The list of eligible candidates will be displayed on the website/outside the school gate on the notice board. No queries will be entertained if the form is rejected. 10. If the names and surnames given in the application form do not match with the birth certificate of the child and the identity proof of the parents, the application
- form will be considered incomplete and will NOT be considered for admission. No changes will be entertained thereafter in the school records. In case of sibling, parents' names to match exactly with sibling's name in Birth Certificate. No spelling differences will be entertained.
- 11.No alteration will be permitted in the registration form once the same has been submitted. Hence you are strongly advised, if you so desire, that the necessary rectifications like addition/deletion of the name/surname/parent's name/s is done legally from the Issuing Authority before submission of the Application Form.
- 12.In case it comes to the knowledge of the management, on detailed verification of the documents submitted, or at any point thereof, that the information furnished is incorrect or wrong, or the documents submitted have been forged/ fabricated/tampered with, the admission will stand cancelled forthwith, without any notice and without having any right to claim or refund of the fee paid. The management also reserves the right to initiate appropriate proceedings in case of any of the above contingencies.
- 13. Application/draw does not guarantee admission. The admission process will be considered complete only on completion of all formalities of admission, verification of all documents and payment of fees within the stipulated time.

14. Both parents must be present with the child on the day of admission as the signatures of both are imperative.

- 15. Originals of all documents must be produced at the time of admission, to permit verification. In case, on verification or at any subsequent point of time, any Document is found to be fabricated, forged or tampered with, the management reserves the right to cancel the admission forthwith.
- 16. Please ensure that the acknowledgement slip is retained and produced whenever you come to the school regarding all future dealings pertaining to admissions. 17. The School being a minority institution reserves its constitutional right to give preference to children from the Christian Community. Preference will also be given to siblings, Wards of Alumni, Management and Wards of Staff. (Only wards of those Alumni, will be considered in Alumni category who have studied in the school for a minimum period of ideally 5 years and who have ideally been supportive of the school.) Conditions apply.
- 18. Please note: Also if applications for these categories exceed the number of seats available, a draw of lots will be held within the various categories. You are therefore, advised to apply in other schools as well in the interest of your child's future. Please note that your child will be considered only under the category you apply for.
- Kindly note: Preference does not guarantee admission. All alumni are requested to attach the documents listed as well as lists detailing how they have been supportive to Sacred Heart Sr. Sec. School.
- 19. With the firm belief that children should not be exposed to the stress of long journeys, parents are advised to opt for neighbourhood schools. The school is not responsible for providing transport facilities. There are, however, a few private contractors plying buses, under contract with the school. The buses are being run on pre-designated routes. The routes on which the buses are plying are available on the school website. Parents are therefore advised to apply to neighbourhood schools. Please note that parents will be responsible for arranging transportation for their child if no seat is available on the buses or the child stays outside the already designated routes. Please note: NO REQUESTS FOR NEW ROUTES/CHANGE IN ROUTES WILL BE ENTERTAINED.
- Please note: Parents using other means of transport barring the buses which are currently on contract with the school, will be responsible for making safe arrangements of transportation for their children. This includes verification of drivers of the vehicle and all other requirements as directed by the CCPCR, CBSE, Central Government and Administration, Hon'ble Punjab and Haryana High Court etc. Parents are therefore advised to take admission in schools near their residence.
- 20. The school has already implemented numerous safety and security measures which are detailed on the school website <u>http://www.sacredheartchd.com</u>. Parents are requested to go through the safety and security measures and apply only after they are satisfied with the measures in place. No objection to the measures will be entertained once a child has been admitted to the school.
- 21. Regarding school rules: Parents are expected to strictly adhere to the rules in the interest of the discipline and safety and security of their children as well as the upbringing of a well- rounded human being. Timings must be strictly adhered to especially as regards the dropping and pick up timings from school, as per school rules. 22.Please note that at the time of admission and at all times thereafter, the medical details and record of the child shall be disclosed to the school keeping in mind the best interests and welfare of the child. Any previous medical history/or any other information pertaining to the child's physical, emotional and mental health must be disclosed. Please note: Parents are requested to disclose all information as it may be vital in case of an emergency and in the handling of your child. Parents will be expected to submit an undertaking to the effect that no medical issue is being withheld from the school.
- 23.Being a Christian Minority Educational Institution and in imitation of Jesus, who made a preferential option for the poor of society, the school has independently been educating children from the E.D.G.(Economically Disadvantaged Group) since 1986 and currently has nearly 500 students from this category. Kindly Note: This is an entirely voluntary exercise as the school being a Christian Minority, Private, Unaided school does not come under the purview of the RTE in the matter
- 24.Only ONE application form per child is to be uploaded. In the event of it being discovered that more than one application has been uploaded for a child, all such forms will stand rejected and the candidate shall be disqualified and not be considered for the Draw of Lots. 25. Forms and all the accompanying documents/photographs, once submitted, will become the property of the school and **shall not be returned.**

26. At the time of submission of forms:

- A sum of Rs. 150/- (non-refundable) is to be paid.
- b) Kindly bring along the <u>Original Date of Birth Certificate</u> for verification purposes. The same will be returned immediately.
 c) There will be a preliminary examination of the forms. All forms found incomplete/ with documents missing/unattested/ with incorrect information will be rejected.
- d) The accepted forms will, thereafter, be subjected to further detailed scrutiny after which the final **list** of eligible candidates **for draw of lots** will be prepared. 27. The final list of eligible candidates for the draw of lots will be put up on **16th January**, **2025 outside the school**.
